Effective on or about March 26, 2024 at 1200 Coordinated Universal Time (UTC), the National Centers for Environmental Prediction (NCEP) will implement the first version (1.0) of the Environmental Modeling Center (EMC) Verification System (EVS). The EVS is designed to provide information on real-time EMC model performance through the display of graphics on the EMC web page.
